In-Person Events Banned Through July 4

As the COVID-19 pandemic continues to work its way across our nation, we are monitoring developments and adapting. As of early April, many of our nation's large cities see their medical communities stretched to – and, in some cases, beyond – their capacity to meet vital needs. Kansans are facing the pandemic as well, but experts say the major impact of the virus' spread remains ahead of us.

While we all want to return to normal, that appears to be well ahead of us, too – several weeks, at least. Because of this, K-State Research and Extension will extend its ban on all face-to-face extension programs, meetings and events through July 4, 2020.

We did not take this decision lightly. We are doing this for three main reasons:

- The health and well-being of our participants, employees and volunteers must be our top priority.
- Presently, we cannot assure the well-being of our participants, employees and volunteers with an acceptable level of certainty.

In order to ensure quality programs for late spring/early summer, we need to shift from preparation and planning for face-to-face activities to alternative activities.

This includes several 4-H camps and in-person events as well as agricultural field days, health-oriented events, food-safety trainings, county fair judge trainings, and more.

Please note that this does not include county fair season. Fairs are governed by local county fair boards, not K-State Research and Extension. Preparation for fairs will continue as much as possible. In case it becomes necessary, we are looking at alternative methods that would enable 4-H youth to showcase their projects.

We will make every effort to shift as many of these events as possible to internetbased training sessions. But in some cases, such as youth camps, we are heartbroken to know there is not an adequate online replacement for those lifelong memories.

Instead, we look forward to a time, hopefully soon, when all of our in-person activities can begin again, and we can greet you with a smile – face to face.

CARES Act and Family First Act Programs Will Directly Benefit Producers

\$9.5 billion in direct relief to livestock producers, dairy and specialty crops (including those who sell to farmers markets and direct to schools/restaurants) was included in the CARES Act. We are still waiting on how that will be divided among producers. That will come through USDA-FSA.

There are other programs, namely the Paycheck Protection Program (PPP), and other small business loans that will benefit producers. They will need to talk to their lender (they have to apply through SBA, but not all lenders will be able to do this) and accountant/tax preparer to help make these decisions.

Fundraiser site to help Seward County people impacted by COVID 19

A fundraising site, "Response to COVID-19: Seward County, Kansas" has been set up to leverage dollar-for-dollar matching funds (up to \$10,000) from the Kansas Health Foundation. The site, <u>https://ioby.org/pro.../response-covid-19-seward-county-kansas</u>, is now active and accepting donations. All donations are tax-deductible and will be matched up to \$1,000 per donor. The goal set is \$20,655.

The funds will be managed by Genesis Family Health, Seward County United Way, and the Liberal Area Coalition for Families. They are currently developing the criteria and procedure for how the funds will be distributed to individuals.

Coronavirus and Food Safety

A novel coronavirus is a new coronavirus that has not been previously identified. The virus causing coronavirus disease 2019 (COVID-19), is not the same as the <u>coronaviruses that commonly circulate among humans</u> and cause mild illness, like the common cold.

Can a person become sick with COVD-19 from food? According to the Centers for Disease Control and Prevention "We are not aware of any reports at this time of human illnesses that suggest COVID-19 can be transmitted by food or food packaging. However, it is always important to follow good hygiene practices (i.e., wash hands and surfaces often, separate raw meat from other foods, cook to the right temperature, and refrigerate foods promptly) when handling or preparing foods."

Handwashing is important in every day life. This includes:

- Food preparation and eating
- · Caring for someone who is sick
- After using the bathroom or changing a diaper
- After blowing your nose, coughing or sneezing
- Touching animals, pet waste, pet food
- After handling garbage.

Many federal student loans are in administrative forbearance through September 30, 2020. That means NO payments are required at this time and 0% interest on existing balances.

USDA Announces Online Tool to Help Families Find Meals for Kids During COVID-19 Emergency

Interactive map finds free meals during school closures

WASHINGTON, April 3, 2020 – The U.S. Department of Agriculture (USDA) today announced the launch of an online tool – the "Meals for Kids" Site Finder – to help families find meals for children while schools are closed during the coronavirus pandemic. This is the latest in a series of swift actions USDA has taken to keep children and low-income individuals fed during the ongoing health crisis.

The <u>"Meals for Kids" interactive map</u> directs people to local sites where kids can get free meals. The site finder currently lists more than 20,000 meal sites from 23 states, and more sites will be added as states submit data each week. The map is available in both English and Spanish at <u>www.fns.usda.gov/meals4kids</u>.
